Junior Member: (1) Eligibility: Any person 16 through 20 years of age who has a demonstrated interest in participating in and promoting the Development of yachting in all its aspects may apply for membership as a Junior Member. (2) Rights: Junior Members shall have all rights accorded Regular Members except the right to hold office as an Officer or Director. Upon reaching the age of 21, Junior Members may become Regular or Associate Members upon payment of initiation fees, when applicable, and the current membership dues. Junior Membership applications for those 16-17 of age must be signed by a parent or legal guardian.

Additionally, I agree to comply with all rules and sailing instruction governing the races and I agree that any contestant may inspect my yacht before or after any race under jurisdiction of the fleet measurer or Race Committee Chairman. The interpretation of this release and waiver shall be performed as if both parties had an equal opportunity to draft the entire release. I further expressly understand and agree that the foregoing release and waiver is intended to be as broad and inclusive as is permitted by law and that if any portion is held invalid, it is agree that the balance shall continue in full force and legal effect.
