In consideration of the acceptance of my Race Application for myself and my heirs, administrators, executors, successors and assigns, I hereby fully and forever release, hold harmless, defend, acquit and discharge Cortez Racing Association, a California Nonprofit Corporation (CRA), its officers, directors, members, agents, employees and committees from any and all liability for any injury, damage, or claim arising out of, in connection with or from my participation in CRA races, function and events. I agree to accept responsibility for the safety, welfare and conduct of all persons aboard my yacht during any CRA race or function. I agree to maintain and equip my yacht in accordance with all applicable Federal, state and municipal statutes, regulations and rules including those of the U.S. Coast Guard, US Sailing Association and CRA. Additionally, I agree to comply with all rules and sailing instructions governing the race(s), and I agree that any contestant may inspect my yacht before or after any race under jurisdiction of the fleet measurer or Race Committee Chairman. The interpretation of this release and waiver shall be performed as if both parties had an equal opportunity to draft the entire release. I further expressly understand and agree that the foregoing release and waiver is intended to be as broad and inclusive as is permitted by law and that if any portion is held invalid, it is agreed that the balance shall continue in full force and legal effect.

I have read **The Fine Print** and agree to all provisions therein. I will abide by all applicable rules, the Sailing Instructions, and will inform my crew that inappropriate conduct at the hosted post race parties will not be tolerated.
