- d. Proposed Duties of Craft Master:
 - 1. To ensure the boat is ready for the use of CRA/SWYC race committees on published dates.
 - 2. To work with the CRA Board to write a maintenance plan both short term and long term.
 - 3. To supervise the implementation of the maintenance plan.
 - 4. To supervise all contractors working on the boat.
 - 5. To assist in training all users and operators of the boat.
 - 6. To work with the CRA Board and Treasurer to ensure all proper bills are paid on time and that a contingency fund is established and funded on a regular schedule.
 - 7. The Craft Master will report monthly to the Board concerning the status of the RC boat Dennis Conner to includes actions and activities that happened during the month.
 - 8. The Craft Master may use the boat for personal recreational cruises up to once per month while adhering to the lease agreement with SWYC. These personal

cruises cannot be accumulated beyond one per month. These cruises can never be for commercial purposes, can never be transferred to anyone without the specific permission of the CRA Board, and may not travel a longer distance than the equivalent distance from San Diego to Mission Bay and back.

Vote: YES unanimous

In the event that a member is unable to complete a term, the Board shall appoint a substitute member to complete the expired term on the committee. Note - from the ByLaws: ARTICLE X: Amendments: These Bylaws may be amended at any time by a majority vote of the membership in attendance at a scheduled meeting of the membership. Amendments may also be ratified by a USPS Mail Vote response or through Electronic (E-Mail or Electronic Document Transfer) communication. A majority vote is based on the number of responses received. No vote will be taken amending the Bylaws without 20 days' notice to the membership. Votes by a USPS Mail Vote response or through Electronic (E-Mail or Electronic Document Transfer) communication will be counted 20 days after members have been notified to vote.
